CHAMBER OF ARCHITECTS

Most of both public and private buildings in Bulgaria are aged do not comply with the current EU energy efficiency standards.

Meeting the EU climate goals for 2030 and 2050 requires an urgent focus on upgrading the existing building stock.

Specialists in assessment, design, construction and implementation are severely lacking.

• Setup one or more information centers where investors and the general public can learn about and get consulted on the topic of energy efficiency


• Combine these centers with commercial and exhibitions spaces where visitors may directly experience, select and get a quote on specific high-efficiency solutions that fit their needs
